MEMORANDUM OF UNDERSTANDING (MoU)

MADE THIS DAY, THE ELEVENTH OF SEPTEMBER 2019,

BETWEEN

Ramakrishna Mission Vivekananda Educational and Research Institute (RKMVERI), an Institution Deemed-to-be-University as declared by the Ministry of Human Resource Development (MHRD), Government of India, on the advice of University Grants Commission (UGC), under Section 3 of UGC Act, 1956, headquartered at Belur Math, with 'Off-Campus' Centres approved by UGC/MHRD across the country (hereinafter called RKMVERI, the First Party) of the FIRST PART

AND

Achhram Memorial College P.O. Jhalda; Dist. Purulia (hereinafter called 'Achhram Memorial College', the Second Party) of the OTHER PART

WHEREAS RKMVERI, the First Party, being a multi-campus University conceived, conceptualized and established by Ramakrishna Mission to actualize the educational vision of Swami Vivekananda—with a wide range of unique 'thrust areas' operationalized through the following Faculties/Schools: School of Rehabilitation Sciences (having Faculties of Disability Management Special Education and General & Adapted Physical Education and Yoga) School of Agriculture and Rural Development (having the Faculty of Integrated Rural & Tribal Development and Management), School of Mathematical Sciences (having the Departments of Mathematics, Physics and

Computer Science), School of Indian Heritage (having the Department of Sanskrit & Philosophy, Ancient & Modern Scriptural Studies)—has been awarded by National Assessment and Accreditation Council (NAAC) the highest grade of A++ with Cumulative Grade Point Average of 3.66 out of 4,

WHEREAS RKMVERI, the First Party, has been selected by University Grants Commission (UGC) under its Scheme PARAMARSH as a Mentor Institution to mentor, assist and provide all possible help to the Achhruram Memorial College (AMC), the Second Party, in the matter of getting assessed and accredited by NAAC in the Revised Accredited Format (RAF),

WHEREAS the Achhruram Memorial College's Principal, having felt that the mentoring by RKMVERI which has been awarded the highest grade of A++ by NAAC with CGPA 3.66 out of 4, would be immensely beneficial for AMC, has consented for AMC being a Mentee Institution with RKMVERI as the Mentor Institution under the said UGC Scheme PARAMARSH for the purpose of assessment and accreditation by NAAC in the Revised Accreditation Format,

THEREFORE the two Parties, RKMVERI and the Achhruram Memorial College agree as follows:

- (1) THAT RKMVERI and Achhruram Memorial College shall be related to each other as Mentor-Mentee Institutions respectively as defined and conceived by UGC in its PARAMARSH Scheme in the matter of the NAAC accreditation process,
- (2) THAT, while the Mentor Institution RKMVERI shall provide all types of assistance, help, service and support to the Mentee Institution Achhruram Memorial College, the Mentee Institution shall also cooperate, collaborate and work in partnership with the Mentor Institution in order to derive maximum benefit out of this fruitful association made possible by UGC under the PARAMARSH Scheme,
- (3) THAT the Mentor-Mentee association between the First and Second Parties will continue as long as the PARAMARSH Scheme of UGC continues to operate effectively and is in force; it shall cease formally once the Scheme is called to a close by UGC, but informal academic association could continue between the two Institutions through sharing of knowledge and experience for the mutual benefit of both to enhance quality and achieve excellence,
- (4) THAT RKMVERI and Achhruram Memorial College shall always endeavour to abide by the noble spirit as well as the rules and regulations of the UGC Scheme PARAMARSH, uphold the highest standards of academic integrity

and strive for enhancing quality to achieve all-round excellence in the field of higher education,

- (5) THAT any dispute regarding the implementation and/or interpretation of the present MoU agreement shall be settled through mutual discussions, consultations and deliberations between the two Parties in a spirit of cooperation and cordiality.

Netaji Subhas Ashram Mahavidyalaya, Suisa, Purulia, West Bengal and Achhruram Memorial College, Jhalda, Dist- Purulia, West Bengal wishing to establish relations between the two institutions, agree to cooperate with each other as follows:

Subject to mutual consent, the areas of cooperation will include any programme offered at either institution as thought desirable and feasible on either side and that both sides will contribute to the fostering and development of the cooperative relationship between the two colleges. Cooperation shall be carried out through such activities as:

1. Exchange of faculty
2. Joint research activities and publications
3. Participation in seminars and academic meetings
4. Exchange of academic materials and other Information

Exchange of faculty

- I. The two Colleges will actively seek to promote mutual faculty exchange for mutual agreed periods.
- II. Faculty exchange may assume various forms, such as individual short-time and long-term visits of faculties, joint research and development projects

Joint research activities and publications

- I. All the faculty members of both the colleges can take part in any major or minor research projects mutually.
- II. Faculties can publish their articles and research papers in the journals published by the departments as well as published by the colleges.

Participation In seminars and academic meetings

- I. All the faculty members can attend seminars and academic meetings organized by the both colleges.


Exchange of academic materials and other Information

1. Information will be actively exchanged, including information for students, information on research and study provided at the college, relevant information about faculty members and fields of research, and college publications.

TERMS OF IMPLEMENTATION, RENEWAL REVISION, CANCELLATION AND NOTICES

1. Details of the implementation of any particular exchange resulting from this MoU shall be negotiated between the two colleges.
2. This MoU becomes effective on the day it is signed and remains valid for five years.
3. This MoU will be renewed after five years upon the consent in writing of both colleges. Each college may cancel the MoU by notifying the other college of its intent to do so at least six months in advance of the date of expiration. Projects in progress at the time of termination will remain unaffected.
4. Any amendment or modification to the present text shall be submitted for review to the competent authorities, and shall not binding unless reduced to writing and signed by both the colleges.
